ANNOUNCEMENT OF OFFER PRICE AND ALLOTMENT RESULTS

SUMMARY

Offer Price and Net Proceeds

- The Offer Price has been determined at HK\$1.25 per Offer Share (exclusive of brokerage of 1%, SFC transaction levy of 0.0027% and Stock Exchange trading fee of 0.005%).
- Based on the Offer Price of HK\$1.25 per Offer Share, the net proceeds from the Global Offering to be received by the Company (before any exercise of the Over-allotment Option and without taking into account the Shares to be issued upon exercise of options which may be granted under the Share Option Scheme), after deducting the underwriting commission and fees and other estimated expenses payable by the Company in relation to the Global Offering, are estimated to be approximately HK\$261.6 million. The Company currently intends to apply such net proceeds in accordance with the purposes set out in “Future plans and use of proceeds” of the Prospectus.

Applications Under the Hong Kong Public Offering

- The Offer Shares initially offered under the Hong Kong Public Offering have been very significantly over-subscribed. A total of 15,119 valid applications were received pursuant to the Hong Kong Public Offering on **WHITE** and **YELLOW** Application Forms and through giving **electronic application instructions** to HKSCC via CCASS and through the **HK eIPO White Form** Service Provider under the **HK eIPO White Form** service for a total of 4,854,368,000 Hong Kong Offer Shares, representing approximately 161.8 times of the total number of 30,000,000 Hong Kong Offer Shares initially available under the Hong Kong Public Offering.
- Because of the over-subscription in the Hong Kong Public Offering, the reallocation mechanism as described in “Structure of the Global Offering – Hong Kong Public Offering – Reallocation” of the Prospectus has been applied. A total of 120,000,000 Offer Shares have been reallocated from the International Placing to the Hong Kong Public Offering. As a result, the final number of the Hong Kong Offer Shares is 150,000,000 Offer Shares, representing 50% of the initial number of the Offer Shares (before any exercise of the Over-allotment Option and without taking into account the Shares to be issued upon the exercise of options which may be granted under the Share Option Scheme).

International Placing

- The Offer Shares initially offered under the International Placing have been slightly over-subscribed. The final number of Offer Shares under the International Placing is 150,000,000 Offer Shares after reallocation to the Hong Kong Public Offering, representing 50% of the total number of the Offer Shares under the Global Offering (before any exercise of the Over-allotment Option and without taking into account the Shares to be issued upon the exercise of options which may be granted under the Share Option Scheme). Before the said reallocation, the initial number of the Offer Shares under the International Placing was 270,000,000 Offer Shares. Pursuant to the International Placing, a total of 63 places have been allotted International Placing Shares of five board lots or less, representing approximately 36.0% of the total number of the 175 places under the International Placing. A total of 310,000 International Placing Shares have been allocated to these places, representing approximately 0.2% of the 150,000,000 International Placing Shares after re-allocation to the Hong Kong Public Offering (before any exercise of the Over-allotment Option).
- Pursuant to the Cornerstone Investment Agreements with the Cornerstone Investors, the number of Offer Shares subscribed for by the Cornerstone Investors has now been determined. Each of Gain Asset Management Limited, Mr. Deng Jian Jun and Mr. David Kwan has subscribed for 52,000,000 Offer Shares, 30,400,000 Offer Shares and 16,000,000 Offer Shares, respectively. The total number of Offer Shares subscribed by the Cornerstone Investors is 98,400,000 Offer Shares, representing approximately 32.8% of the number of Offer Shares offered pursuant to the Global Offering or approximately 8.2% of the Company's total issued share capital following completion of the Global Offering, assuming that the Over-allotment Option is not exercised and without taking into account the Shares to be issued upon the exercise of options which may be granted under the Share Option Scheme. Please refer to the "Cornerstone Investors" of the Prospectus for further details of the Cornerstone Investors.
- None of the Sole Sponsor, the Joint Global Coordinators, the Joint Bookrunners, the Joint Lead Managers and the Underwriters and their respective affiliated companies and connected clients of the lead broker or of any distributors (as defined in the placing guidelines for equity securities as set forth in Appendix 6 to the Listing Rules ("**Placing Guidelines**")) has taken up any Offer Shares for its own benefit under the Global Offering, whether in their own names or through nominees. The Directors confirm that no Offer Shares have been allocated to applicants who are core connected persons, directors or existing shareholders of the Company or their respective close associates within the meaning of the Listing Rules, whether in their own names or through nominees. The International Placing is in compliance with the Placing Guidelines and no Offer Shares placed by or through the Joint Global Coordinators and the Underwriters under the Global Offering have been placed with any core connected person (as such term is defined in the Listing Rules) of the Company or persons set out in paragraph 5 of the Placing Guidelines, whether in their own names or through nominees. No placee will, individually, be placed with more than 10% of the enlarged issued share capital of the Company immediately after the Global Offering. None of the places under the International Placing will become a substantial shareholder (as defined in the Listing Rules) of the Company after the International Placing and the number of Shares to be held by the public will satisfy the minimum percentage prescribed by Rule 8.08 of the Listing Rules. The Directors confirm that the three largest public shareholders of the Company do not hold more than 50% of the Shares held in public hands at the time of the Listing in compliance with Rules 8.08(3) and 8.24 of the Listing Rules. The Directors confirm that there will be at least 300 Shareholders at the time of the Listing in compliance with Rule 8.08(2) of the Listing Rules.

Over-allotment Option

- In connection with the Global Offering, the Company has granted the Over-allotment Option to the International Underwriters exercisable at the sole discretion of the Joint Global Coordinators (for themselves and on behalf of the International Underwriters) at any time from the date of the International Underwriting Agreement until 30 days from the date of the last day of lodging application under the Hong Kong Public Offering (i.e. 8 March 2018), to require the Company to issue and allot up to 45,000,000 additional Shares, representing 15% of the number of the Offer Shares initially available under the Global Offering (before any exercise of the Over-allotment Option and without taking into account the Shares to be issued upon the exercise of options which may be granted under the Share Option Scheme), at the same price per Offer Share under the International Placing to cover over-allocation in the International Placing, if any, on the same terms and conditions as the Offer Shares that are subject to the Global Offering. There has been an over-allocation of 45,000,000 Shares in the International Placing. Such over-allocation will be covered by exercising the Over-allotment Option, by making purchases in the secondary market at prices that do not exceed the Offer Price, through deferred settlement, or by a combination of these means. NET PROCEEDS FROM THE GLOBAL OFFERING

Based on the Offer Price of HK\$1.25 per Offer Share, the net proceeds from the Global Offering to be received by the Company (before any exercise of the Over-allotment Option and without taking into account the Shares to be issued upon exercise of options which may be granted under the Share Option Scheme), after deducting the underwriting commission and fees and other estimated expenses payable by the Company in relation to the Global Offering, are estimated to be approximately HK\$261.6 million.

The Company currently intends to apply such net proceeds as follows:

- approximately HK\$112.4 million, representing approximately 43.0% of the net proceeds from the Global Offering, will be used for financing the issuance of performance bonds when undertaking new projects;
- approximately HK\$61.0 million, representing approximately 23.3% of the net proceeds from the Global Offering, will be used for strengthening our storage facilities for equipment and materials by acquiring a warehouse;

Please refer to the section headed “Cornerstone Investors” in the Prospectus for further details relating to the Cornerstone Investors.

None of the Sole Sponsor, the Joint Global Coordinators, the Joint Bookrunners, the Joint Lead Managers and the Underwriters and their respective affiliated companies and connected clients of the lead broker or of any distributors (as defined in the Placing Guidelines) has taken up any Offer Shares for its own benefit under the Global Offering, whether in their own names or through nominees. The Directors confirm that no Offer Shares have been allocated to applicants who are core connected persons, directors or existing shareholders of the Company or their respective close associates within the meaning of the Listing Rules, whether in their own names or through nominees. The International Placing is in compliance with the Placing Guidelines and no Offer Shares placed by or through the Joint Global Coordinators and the Underwriters under the Global Offering have been placed with any core connected person (as such term is defined in the Listing Rules) of the Company or persons set out in paragraph 5 of the Placing Guidelines, whether in their own names or through nominees. No placee will, individually, be placed with more than 10% of the enlarged issued share capital of the Company immediately after the Global Offering. None of the placees under the International Placing will become a substantial shareholder (as defined in the Listing Rules) of the Company after the International Placing and the number of Shares to be held by the public will satisfy the minimum percentage prescribed by Rule 8.08 of the Listing Rules. The Directors confirm that the three largest public shareholders of the Company do not hold more than 50% of the Shares held in public hands at the time of the Listing in compliance with Rules 8.08(3) and 8.24 of the Listing Rules. The Directors confirm that there will be at least 300 Shareholders at the time of the Listing in compliance with Rule 8.08(2) of the Listing Rules.
